UBF Faculty-Student Housing Corp. is a New York not-for-profit corporation, which was created for the purpose of developing, constructing and operating student housing for the University at Buffalo.

UBF Faculty - Student Housing Corp., is seeking to take advantage of favorable interest rates to refund 2012A Tax-Exempt Bonds, fund debt service reserve fund and pay costs of issuance. The original tax-exempt bond issue was in the amount of \$32,465,000. This 2021 tax-exempt bond issue is approximately \$28,000,000 with a not to exceed amount of \$30 million.
