Amherst Sweethome Rd Property, LLC, on behalf of itself or an affiliate, subsidiary or other entity formed or to be formed (the "Applicant") has submitted an application to the Agency requesting the Agency to undertake a certain project (the "Project") consisting of: (a) the acquisition of a leasehold interest in a 2.33 +/- acre parcel of land located at 1265 Sweet Home Road; (b) the construction/re-construction thereon of a multi-family, market-rate housing development to include up to 154 units totaling 105,738 square feet and related amenities and improvements (the "Improvements"); and (c) the acquisition and installation therein, thereon or thereabout of certain machinery, equipment and related personal property (the "Equipment").
